LLC member resolutions. This is a pretty simple document. A lot of times a bank may request a copy of a LLC resolution by the members giving the members authority to open a bank account on behalf of the LLC. LLC Resolution Contents. LLC resolutions describe in writing what action the resolutions authorize, including appointing one or more individuals to sign documents or carry out other acts implementing the resolution. The required number of members or managers must sign the resolution.

However, one key difference between the corporation and the LLC is that the LLC offers enhanced management flexibility over a corporation. The members of the LLC can adopt certain corporate formalities, i.e. using a corporate resolution form. As previously noted, while the corporate resolutions are optional for an LLC, they are highly advisable.
